The Pacific Northwest Hickory Championship will be a two-day gross and net competition with awards for Open, Senior (60-69), Statesmen (70+) and Women's Divisions.

**EQUIPMENT:** Hickory-shafted clubs as approved by the Society of Hickory Golfers. Period attire is encouraged. Rental clubs are available.
